

Privacy Policy

MYRUBY RESPECTS THE PRIVACY OF EVERY INDIVIDUAL WHO VISITS THIS SITE. This Privacy Policy explains how myruby.co.uk collects and processes personally identifiable information. We operate within Data Protection and Privacy legislation in the UK and are fully registered under the UK Data Protection Act 1998.

- We only hold data (e.g. personal and company information) to support the business service that we provide to our clients.

Information is gathered in two ways: (1) indirectly, i.e., certain anonymous information about all visitors, such as domain name, browser type and page views, which is collected through our site's technology and is not linked to individual identities; and (2) directly, when you voluntarily submit Personal Information such as, first and last names, addresses and email addresses, on www.myruby.co.uk.
